

Infant Free Meal Registration Form

This form is to register for infant free school meals, which are available from September 2014 to all pupils in Reception, Year 1 and Year 2, regardless of family income. To maximize the funding the school gets from the government, we also need to know which of our children would be entitled under the ordinary conditions. Additional funding of £1,300 per year is paid for each child registered as entitled under the ordinary conditions. This is why some of the questions are quite detailed.* You do not need to provide evidence of entitlement. EVEN IF YOU DON'T WANT TO TAKE FREE MEALS, WE WOULD STILL LIKE YOU TO REGISTER FOR THEM, SO THAT WE GET AS MUCH GOVERNMENT FUNDING AS POSSIBLE!
